The underlying portfolios may invest in, amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, bonds, other interest bearing instruments and financial instruments.

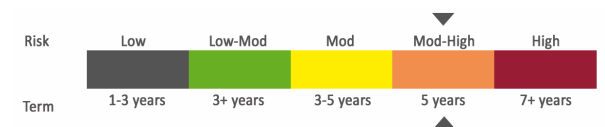

## RISK PROFILE



### Moderate - High Risk

- Therefore, it is suitable for medium to long term investment horizons.

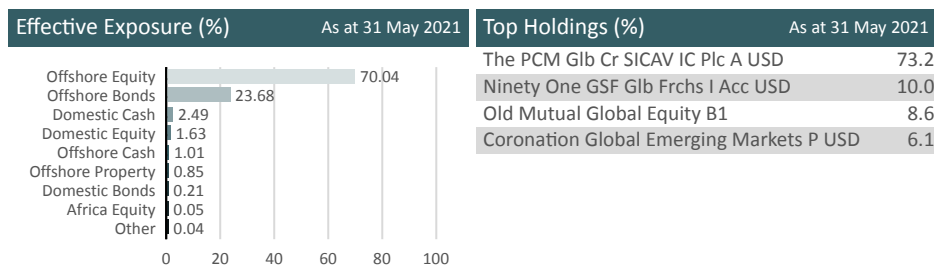
